Position Overview

The Manager Regulatory Affairs serves the interests of the Canadian railway industry in line with RAC policy directions and strategies by providing support on safety and operations regulatory activities, including awareness and compliance services provided by the Railway Association of Canada (RAC) to its members.

The Responsibilities

- Provide support to the Senior Director Operations and Regulatory Affairs and RAC subcommittees in the development and amendments of:
 - Legislative positions (Acts and Regulations)
 - Rules under the Railway Safety Act
 - o Industry Standards
 - Guidelines and RAC Circulars
 - Related research and position papers
 - Strategies related to railway operations, safety, security, and the environment;
- Research and review regulations, rules, standards, and other benchmarks.
- Draft, on behalf of the industry, submissions to address various regulatory matters;
- Coordinate with Federal and Provincial Government (including Transport Canada, Transportation Safety Board, Canadian Transportation Agency), Regulatory Committees and Working Groups;
- Stay informed of regulatory changes, industry practices and new developments, and inform the Senior Director Operations and Regulatory Affairs and membership accordingly;
- Coordinate strategies and programs, with members and regulators, that promote understanding, awareness and compliance of the regulatory processes and specific Acts, rules, regulations, and guidelines, through workshops, events and programs, written communications, etc.;
- Support the Senior Director Operations and Regulatory Affairs in liaising with U.S. railway
 organizations (AAR, ARRSLA, APTA, AREMA, etc.) and regulatory agencies (DOT, FRA, NTSB,
 etc.). Coordinate joint efforts, resources, and information as necessary and appropriate;
- Perform scheduled and ad-hoc regulatory assessments.

Professional Experience and Qualifications

- University degree in a relevant discipline such as public policy and administration, law, engineering, business;
- Experience in the railway industry or other regulated, safety-sensitive, and supply-chaincritical industry. Operations experience an asset;
- Able to navigate and decipher regulations and rules;
- Must be able to develop and maintain effective working relationships with internal and external parties;
- Able to respond effectively to the positions and reactions of others;
- Knowledge of North American railway regulatory requirements an asset;
- Previous experience with an industry association an asset;
- Proficiency in both official languages preferred.
